Operation Instruction

- TTU-WHS-D works with all Wireless Ready TTU units.
- Press and hold the MUTE, the LISTEN volume down key and the Power on/off key simultaneously then release the MUTE and LISTEN volume down key to enter the USER'S MANUAL
 - Keep press the LISTEN volume key to obtain the HS ID that matches the RF ID on the TTU-WR unit. Continue to press the Mic MUTE key until the display turns off.
- Press and hold the power ON/OFF button to turn the unit on and off.
- Press the UP or DOWN triangle key to increase or decrease the TALK or LISTEN volume.
- Press the square Mic MUTE key once to turn off the operator's microphone.
 Press once again to turn on the microphone again.
